### DIRECT DEPOSIT AVAILABLE FOR 2021-2022

During the 21-22 academic year, all financial aid, after fees are paid, will be disbursed by paper check to the mailing address you have on file or by Direct Deposit [click here [for instructions to Sign Up for Direct Deposit](#)]. It is important that you verify your mailing address in MySDCCD or sign up for Direct Deposit no later than 3 weeks prior to any posted date shown below. For the first grant dates shown, please verify or update your mailing address or Direct Deposit by September 1, 2021 first Fall 2021 semester disbursement. If your mailing address or Direct Deposit information is correct, no further action is required. (for loans; deadline to enroll in Direct Deposit – 07/31/2021). As files are packaged, new awards are disbursed on a weekly basis.

### STUDENTS AWARDED AFTER THE SCHEDULED PAYMENT DATES

Students eligible for disbursement after the first scheduled payment date listed above will have their refund check processed on the next scheduled disbursement process date.

### DROPPING OR WITHDRAWING FROM CLASSES

---

Students who drop or withdraw from all classes or students who do not attend a late start class and have received payment for these classes will have their eligibility re-calculated to determine if funds must be repaid. If there is an overpayment, students will be notified separately.

Currently, students do not have to repay the institutional portion of the federal refund. However, in the future, students may be required to repay the institutional refund and if not paid, a hold will be placed on their records.
